I agree that I am a person of integrity and will continue to be a person of good moral character, now and at all times during the Pageant and during my reign as a titleholder for the Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United.

I agree that I am a citizen of the United States of America and a legal resident of the state that I represent, or I attend college or own property in the state of my entry for State, USA entry. OR.....

I agree that I am a citizen of the Country/Nation (outside of the USA) that I am representing.

I agree that I was genetically born female, and will remain female during my reign.

I agree that if I am a married contestant, I have been married for at least 6 months prior to the Worldwide United Crowning Event of Mrs. Worldwide United and that I am married to a genetically born male.

I agree that as a Miss Teen Contestant I am from the ages of 13 to 17 on the date of the Worldwide United Crowning Event of Miss Teen Worldwide United. I agree that I have never been married and I do not have any children.

I agree that as a Miss Contestant I am from the ages of 18 to 30 on the date of the Worldwide United Crowning Event of Miss Worldwide United. I agree that I have never been married and I do not have any children.

I agree that as a Ms. Contestant I am from the ages of 21 +, on the date of the Worldwide United Crowning event of Ms. Worldwide United. I can be single or divorced, with or without children.

I agree that as a Mrs. Contestant I am from the ages of 21 to 56 on the date of the Worldwide United Crowning event of Mrs. Worldwide United. I have been married at least 6 months prior to the date of the Worldwide United Crowning event and will send a copy of my marriage license to Worldwide United Pageants.

I agree that as a Mrs. Classic Contestant I am from the age of 50+ on the date of the Worldwide United Crowning event of Mrs. Classic Worldwide United. I have been married at least 6 months prior to the date of the Worldwide United Crowning event and will send a copy of my marriage license to Worldwide United Pageants.

I agree to send a copy of my birth certificate to Worldwide United Pageants.

I agree that I will conduct myself above reproach and I have not appeared nude or semi-nude in any photographs, video or film or modeling at any time prior to or during the Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United Pageant.

I agree that I will hold to only the highest moral and ethical standards as a titleholder, and I agree to present a positive image of Worldwide United Pageants at all times, before, during and after the international Pageant.

I agree that I will act in a professional manner by being courteous and polite during the Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United Pageant and while representing a state, national, or regional title.

I agree that I will continually act in a professional manner, and be polite and courteous to the directors and other titleholders and will not be late to any of the scheduled events at the Pageant.

I agree that I will not use the title name (such as Miss Teen Worldwide United, Miss Worldwide United, Ms. Worldwide United, Mrs. Worldwide United or Mrs. Classic Worldwide United) in any electronic address or Social Media without the written approval of the Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United Pageant.

I agree that the Fan Pages for Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United on Facebook will be created, supervised and managed by the Director of Worldwide United Pageants. The Worldwide United Titleholders may be given

Editing rights so that they have access to the fan page and can upload their photos and post their appearances. In this regard, Worldwide United Pageant will be able to keep the international Fan Pages running indefinitely each year a new Worldwide United Titleholder is crowned.

I agree that as a titleholder for an individual state or region in the United States, I will create, supervise and manage my own (public figure) fan pages, (this is NOT the international title.)

I agree that as a titleholder for an individual country or national region (other than the United States,) I will create, supervise and manage my own (public figure) fan pages, (this is NOT the international title.)

I agree that I will present a very positive image while networking with sites such as Twitter, Facebook, Instagram, blogging, snapchat or message boards, etc. I will not use any negative postings, inappropriate photos or inappropriate language. Additionally, I agree that I will not publicly post gossip, malicious, and/or slanderous remarks on any public media. I realize that if I do this I will be disqualified immediately.

I agree that if I create an email address with my title I will always use the year of my title. Example: (MrsWorldwideUnited 2016@gmail.com.)

I agree that I will not at any time make comments that are considered to be bullying, false or slanderous, that pertain to my fellow Titleholders, judges, the Mrs./Ms./Miss/Miss Teen/Mrs. Classic Pageant, staff, sponsors, or any party directly related or connected to the Pageant. Any such comment or correspondence may cause me to be disqualified and/or lose my title.

I agree to use good sportsmanship at all times before, during and after the pageant. If I am bullying others or acting in a verbally abusive or disruptive manner I will be disqualified immediately and will be asked to leave the premises.

I will not be managed by any other person or business, other than Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United Pageant in relation to my title, without written permission prior.

The Director must approve all photos and media with the Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United name attached.

All issues relating to a titleholder's poor conduct will be determined solely by the Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United Pageant.

I agree to make a minimum of **TWO** appearances a month during my reign.

I agree that I will return to the 2017 Mrs./Ms./Miss/Miss Teen/Mrs. Classic

Worldwide United Pageant to crown a successor if a pageant is held (Omaha, Nebraska.)

I agree not to compete in any other pageant system during my year's reign.

I agree that if I resign before the 2017 international pageant, I will forfeit my title, crown and sash and will not obtain a refund.

I agree not to participate in: excessive drinking, drunkenness and drug abuse, or any activities that would shock, offend or insult the community.

I agree that if I am arrested or have committed a crime, I will forfeit my title, crown and sash.

I agree not to hold Worldwide United Pageants, and Worldwide Pageant, LLC (including directors and staff) responsible for any injuries, or loss of personal property while I am a titleholder in this pageant.

I agree not to hold Mrs./Ms./Miss/Miss Teen/Mrs. Classic Worldwide United Pageant, and Worldwide Pageants, LLC responsible for any travel expenses or prizes not given (if any) while I am a titleholder in this pageant.

I agree that if I am violating any of the above stated rules, I could forfeit my title, crown and sash.
